SCHEDULE OF INITIAL QUALIFICATION OF STUDENTS OF THE UNIVERSITY CENTER FOR ENVIRONMENTAL STUDIES AND SUSTAINABLE DEVELOPMENT IN ORDER TO BE SENT TO FOREIGN PARTIAL STUDIES (SMS) WITH AN ERASMUS+ SCHOLARSHIP TO UNIVERSITIES FROM THE SO-CALLED PROGRAMME COUNTRIES IN THE ACADEMIC YEAR 2026/2027

1. A set of documents (acceptable scans) should be submitted **by February 18, 2026 (by 3:00 p.m.)** to the Mobility Coordinator, Faculty of Geology, UCBS Directorate Secretariat, room 1103 (or the scans should be sent to the address: adam.tarkowski@uw.edu.pl)
 - qualification application for foreign part-time studies;
 - consent of the thesis supervisor to go abroad for partial studies;
(if the student starts or continues writing a diploma thesis during the trip);
 - a certificate of the arithmetic average of grades for the last year of studies completed before qualification;
 - a document confirming the level of knowledge of the language of instruction of the foreign university;
 - a statement of consent to the processing of personal data in the recruitment process;
 - documents confirming the student's organisational activity presented in the qualification application (i.e. scientific and non-scientific achievements);
 - students of the second year of the Sustainable Development study programme when planning a trip in the summer semester must present the consent of the Course Coordinator and information on the form of passing the following courses: Research Study and Greenwashing.
2. **19 February 2026 – 12.00** – interview (optional) also in English before the Commission composed of:
 - Anna Batorczak, PhD – Chairperson of the Committee;
 - Anna Stachowiak – representative of the Student Council – member of the committee.
 - Dr Adam Tarkowski –Coordinator for Mobility – Member of the Commission;
- 3 **20 February 2026 – by 10.00** – approval by Commission decision
the basic and reserve qualification list of persons nominated for foreign part-time studies;
4. **20 February 2026 – after 3:00 p.m.** – announcement of the results electronically;

5. **until March 6, 2026 – until 12:00 p.m.** – submission of student appeals against decisions Commission to the address adam.tarkowski@uw.edu.pl; consideration by KJD UCBS of possible appeals of students against the Commission's decision. **The appeal is filed through the authority that issued the contested decision – within 14 days from the date of notification in writing or via the IT system of studies (Regulations of Studies of the University of Warsaw – Article 9(3)).**
6. **09 March 2026 until 13.00** – consideration of appeals and re-announcement of results after any positive decisions.
7. **10 March 2026** – the mobility coordinator submits to the BWZ scans of the protocols from the admission procedure together with the lists of students nominated for part-time studies abroad and signed application forms of candidates.
